UE 2016/679, you have the right to lodge a complaint with a supervisory authority ([www.garanteprivacy.it](http://www.garanteprivacy.it)) and, pursuant to article 6 paragraph no. 1, lett. a) and article 9, paragraph no. 2, lett. a), you have the right to revoke your expressed consent at any time.
